



## **GVG Pig Health Scheme**

AHDB's recent bonfire of most significant health initiatives, latterly including Real Welfare and AHDB's Pig Heath Scheme, was not welcomed by many pig farmers – or at least the demise of PHS wasn't!

Many other farmers have quite understandably pretty much forgotten about the scheme, following on from the rather chaotic interruptions of the last few years associated with Covid and contractor staffing problems.

The vet team here at the GVG were just aghast at the AHDB decision to let the axe fall on such an important health initiative. However, economies had to be made, and we are where we are!

As vets we fundamentally believe that health is one of the key pillars of efficient production and indeed linked closely to pig welfare and antibiotic use – important elements in differentiating and enhancing the reputation of British pig meat.

We are therefore very pleased to announce that we will shortly be launching a bespoke GVG Health Scheme to monitor key health parameters in our clients' pigs. The range of conditions monitored will be broadly similar to those you are used to, but we already know we can offer more by applying our field expertise to capture key enteric health markers, as well as the more traditional respiratory health indicators. We are working hard to get our scheme off the ground as soon as possible, hopefully later this Spring. This has only been possible with support and logistical backing from Zoetis Animal Health, to whom we are very grateful. GVG Health Scheme (GHS) will be a subscription service available to all our clients selling pigs into the larger regional plants. With Zoetis support we are really hoping to keep client costs to an absolute minimum, but this will in part be dependent on broad engagement with this project. We really hope you will be able to join us in what we feel is an exciting and worthwhile health initiative for SW pigs. Watch this space!!

Over the last couple of months there have been several report cases of Swine Dysentery, particularly from Yorkshire and Lincolnshire. We have seen these report cases with increasing concern. Unfortunately, there has now also been a report case in our region. Basically, we all just need to be 'on our game' in terms of biosecurity at the moment. Don't overlook the small details like lines of demarcation on loading ramps, occasional visitors like electricians or other tradespeople, etc.
