



### **Security and Biosecurity**

The NPA recently published a warning that incursions on farm are likely to increase over the coming months as the group called 'Animal Rising' have announced they will be embarking on a sustained campaign over the summer and that as part of this, they are planning to 'rescue' animals from farms and abattoirs and potentially stage on-farm occupations. There has been a marked escalation in animal rights activity over the past couple of months and often larger campaigns can incite individuals to conduct their own direct action on local farms they're aware of.

Over time we have become more aware of physical biosecurity on farm, but such a stark warning should not be ignored. It is easy to become complacent and believe that 'it won't happen to me'; however incursions on farm can no longer be classed as unexpected events and can carry longer term consequences for those who are targeted. At best, an increase in audits from APHA, Red Tractor etc will happen. There is also untold stress on owners and staff on units that have had incursions (often repeatedly) and the very real danger of transmissible disease outbreaks.

The NPA have produced a 'Pig Unit Security Pack' and we would encourage all our producers to take some time in heeding their warning and ensuring you have protected your unit as far as possible. On top of practical tips, this pack also includes advice on what to do if you are targeted, or discover unwelcome visitors on your unit. As ever, if you have particular concerns, please speak to one of us.

We will be holding the GVG Pig Fair on Tuesday 24<sup>th</sup> October at Taunton Rugby club. More details to follow – but for now – save the date!


